Improvement Plans to Install Catch Basins
along Imperial Avenue Between 7th Street & Barioni Blvd.***

The City of Imperial is implementing a street improvement project and is requesting proposals from qualified and experienced engineering firms for the above stated project and will receive such bids in the offices of the Planning & Development Department, Engineering Division, at 400 S. Imperial Avenue, Imperial, California 92251 or via email to JVillegas@cityofimperial.org up to the hour of 3:00 P.M. on Tuesday January 27, 2015.

Scope of Work:

1. Improvement Plans:

The work consists of preparing improvement plans to install storm drain catch basins as illustrated on Exhibit "A" and "B" attached to this document for your reference. The City is to provide an Autocad file illustrating field survey data of existing Curb & Gutter and Top-of-Pavement information recently collected as part of its storm drain study titled ***"Field Survey and Mapping of Existing Flowline and Centerline Elevations in Old Town Imperial per Storm Drain Study Area Map"***. All work to be completed within existing City of Imperial public right of way.

2. Cost Estimate:

The work includes the preparation of an Engineer's Opinion of Probable Construction Cost based on Consultant's judgment as a design professional familiar with the local construction industry.

3. Schedule:

The City anticipates the Consultant will provide the services as expeditiously as practicable after receipt of a notice to proceed. The target date for submission of the improvement plans to the City is February 12, 2015.



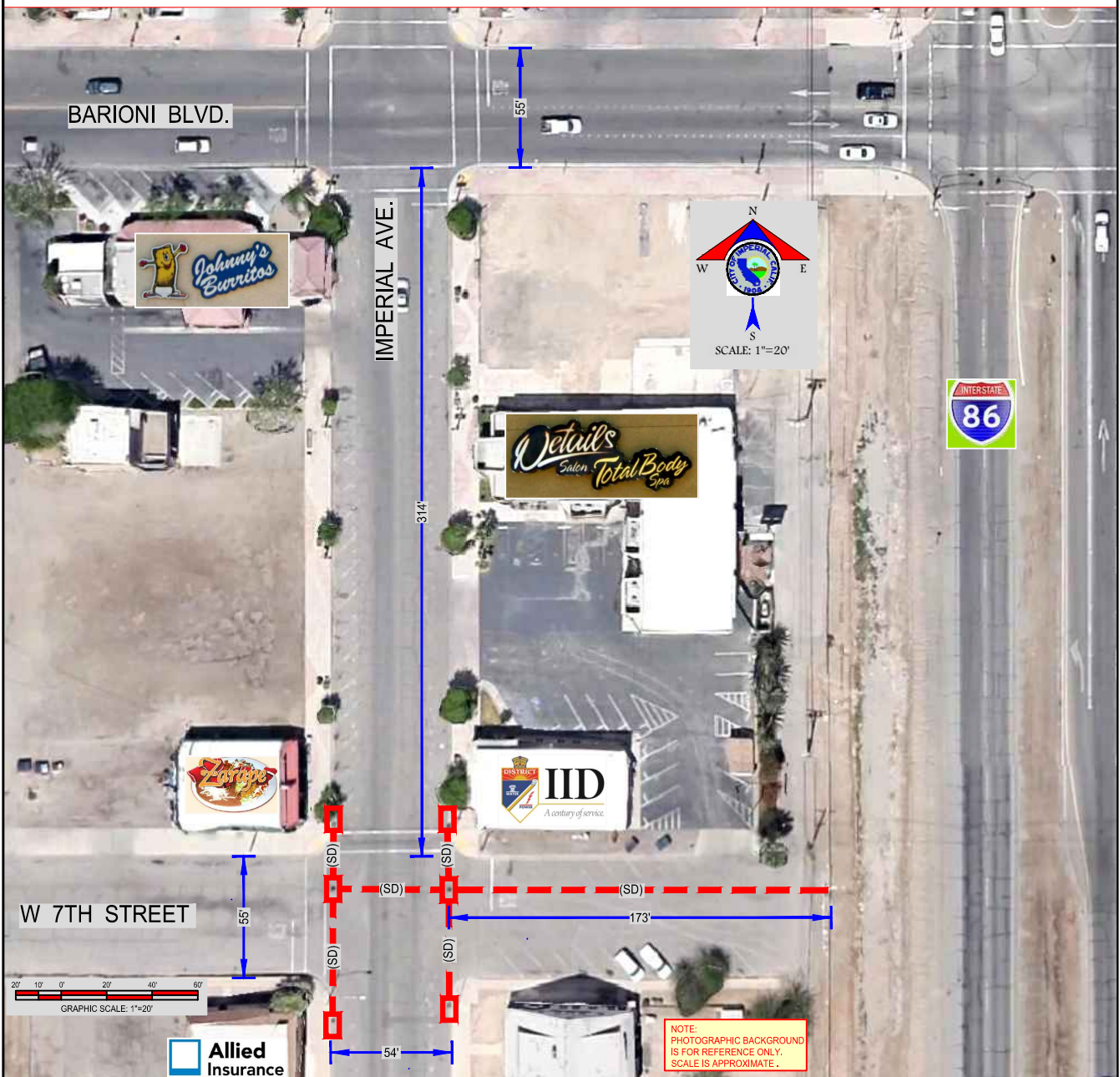
