The public hearing will be held at the City of Imperial Council Chambers located at **200 W 9th Street, Imperial, CA 92251-1637**.

The Public Hearing will be held as an agenda item of the Council Meeting to consider comments on the Draft 2020 Urban Water Management Plan (UWMP) and to formally adopt the UWMP by resolution.

ALL INTERESTED PARTIES are invited to attend said hearing and present oral or written comments on the 2020 UWMP. The City of Imperial hereby releases its Draft 2020 Urban Water Management Plan (UWMP) for public review. The UWMP will be available through Wednesday, January 19th at City Hall located at 420 South Imperial Avenue, Imperial, California 92251-1637, and at the City's Community Development Department webpage <https://www.cityofimperial.org/planning-department>. Please look towards the middle of the webpage to find the Draft 2020 UWMP as well as various other water reports.

The project is categorically exempt from the requirements of the California Environmental Quality Act (CEQA).
