BACKGROUND/SUMMARY: City staff conducted regular field inspections during the construction of the off-site street improvements for the subject project and a final walk through was completed on January 22, 2020. Now the developer is requesting substitution of Trustee and Full Reconveyance with a personal guaranty for the One-Year warranty period.

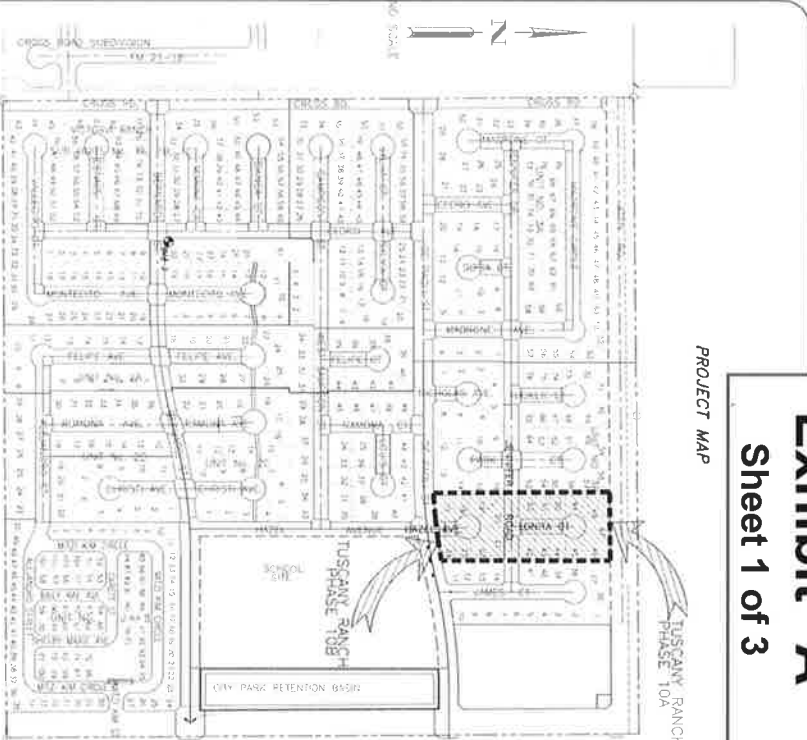

PROJECT MAP

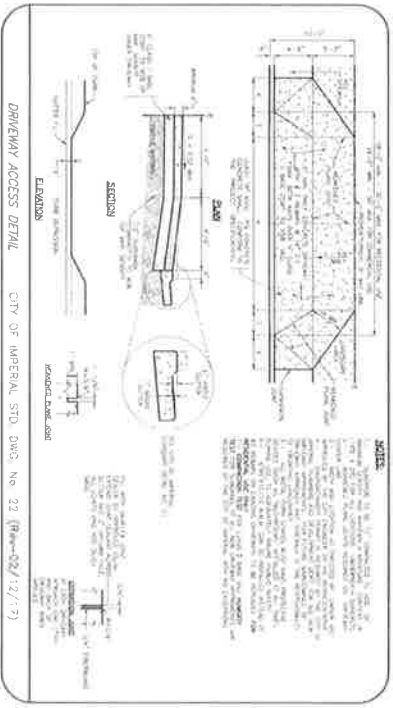
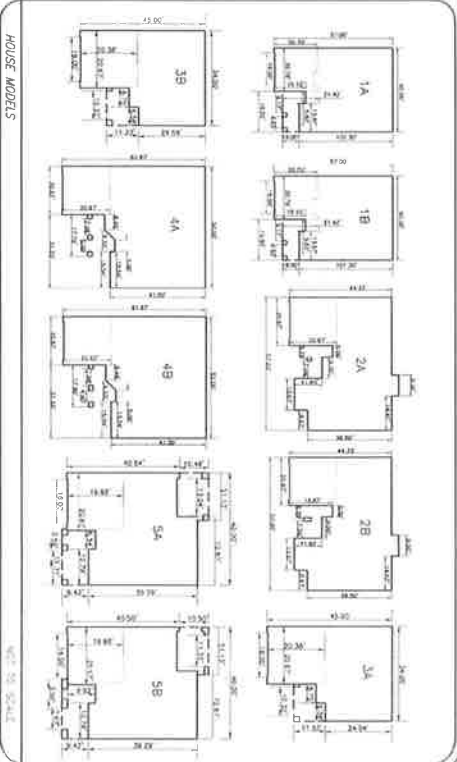


VICINITY MAP

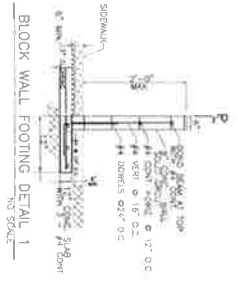
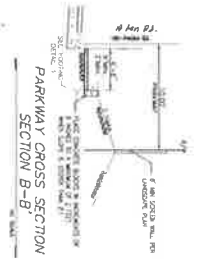
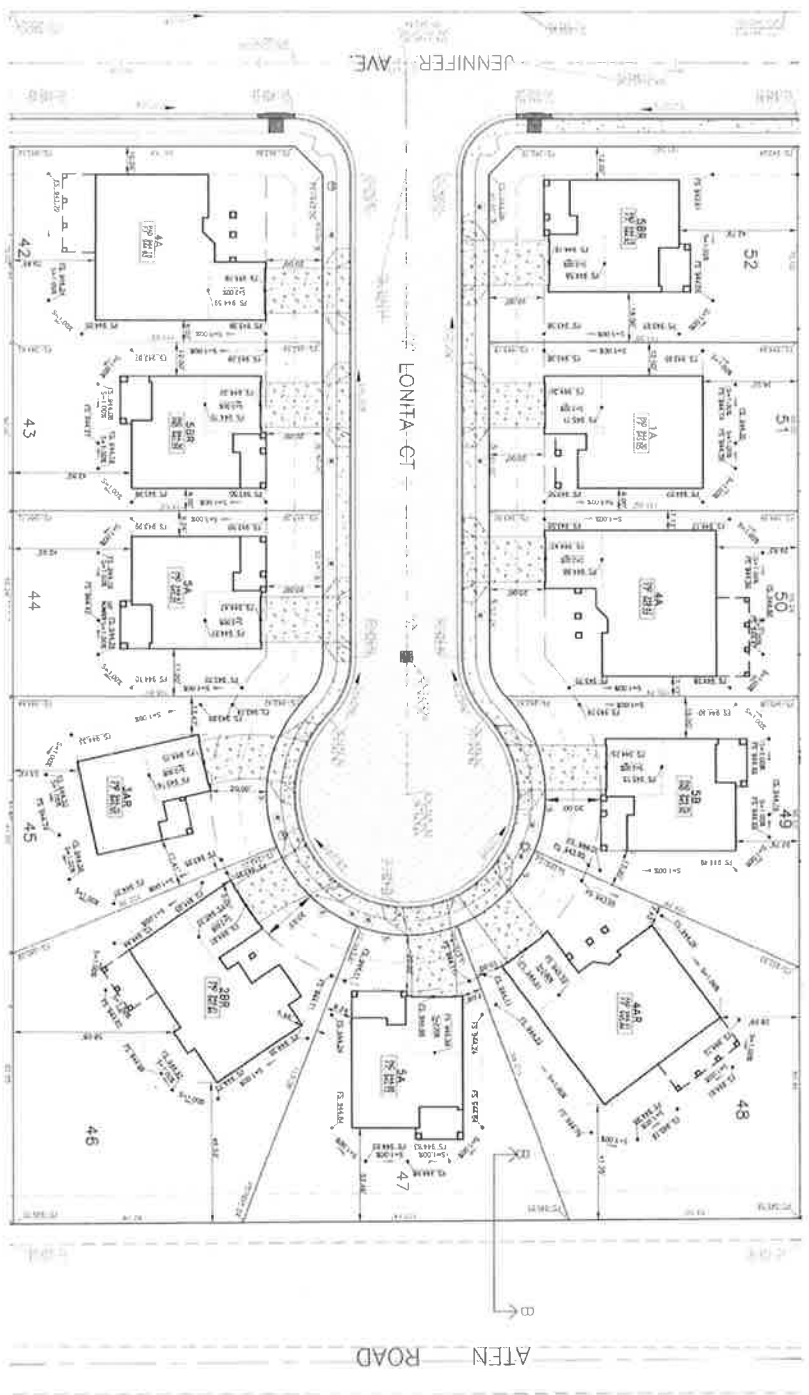
