**DEPARTMENT INVOLVED:** Water

**BACKGROUND/SUMMARY:**

One of the Capital Improvement Projects for the Public Services Department is the replacement of the filter media. The water plant was remodeled in 1995. Media was last replaced in 2005. It is recommended that the media be replaced this year. Bids were solicited and three were received and opened on Tuesday, February 10, 2015. Bidders and amount are as follows:

PMC	\$221,215.00
Prominent Systems, Inc.	\$189,392.00
ERS	\$118,835.07

Staff has reviewed bids received and recommends awarding the bid to ERS in the amount of \$118,835.07. The CIP budget is \$100,000 for this project, leaving a shortage of \$20,000 to complete this project. Staff would like to transfer funds in the amount of \$20,000.

20,000 from fund balance transfer
