 SUBJECT: Modifications in Electrical Work Flow for City Projects
 DEPARTMENT INVOLVED: City Manager, City Attorney, Planning and Public Services Departments
 BACKGROUND/SUMMARY: The City of Imperial currently has numerous projects under construction including library renovation and expansion, downtown streetscape extensions, B Street Pump Station

including library renovation and expansion, downtown streetscape extensions, B Street Pump Station rebuilding, new Head works at the Waste Water Treatment Plant, repairs to Sky Ranch Pump Station, and others. Some of the projects are repairs while others are new public works projects. While these projects for the most part are scheduled improvements, some have been emergency repairs. Several of the scheduled projects have had extended timelines and/or delayed starts due to a lack of responsive bids, construction delays or other work flow issues that have impacted the project timelines such that now many projects are occurring during the same time window. The City originally planned to complete most of the electrical work on many of these projects moving ahead in a timely fashion. The City has some options available to keep projects on track and these differ by project.

<u>For the Library project</u>: According to the Public Contracts Code, the City can ask for a change order from the general contractor, or negotiate an independent electrical contract, including the potential for a time and materials contract, or hire skilled labor. Staff has researched the opportunities with local skilled labor from the Electrical Workers Union and while the quality is recognized, they do not provide liability coverage for their work. The next available option is to consider a change order for DCI to complete the electrical work along with the balance of construction on the site. DCI has provided a price of \$84,140.58 for such a change order, which includes liability protection for the City. The project contingency fund can absorb this cost. Staff is comfortable with the price and the timing will keep the project on track.

<u>For the Downtown project</u>: The City originally only bid the concrete work for the project, and Granite Construction has been awarded this contract. The City did not bid the electrical or landscape work. Since this work has not been bid, staff recommends a delay in the work on the concrete and allow for a bid to be released for the electrical and landscape portion of the project.

FISCAL IMPACT:

An increase in cost of the Library project of \$84,140.58 from the project contingency fund, and a probable cost increase for the Downtown sidewalk project from a new bid for landscape and electrical work.

STAFF RECOMMENDATION:

- 1. Staff recommends moving forward with approval of Change Order #2 for the Library project in the amount of \$84,104.58 for DCI for electrical work.
- 2. Staff recommends proceeding to bid for landscape and electrical work for the Downtown Sidewalk project.
