E-1. SUBJECT: APPEAL OF PLANNING COMMISSION DECISION DENYING A TIME EXTENSION, AMENDMENTS TO CONDITIONS OF APPROVAL AND REVOCATION OF CUP 19-06 LOCATED AT 2475 CLARK ROAD, IMPERIAL, CA AS REQUESTED BY JUSTO FELIX.

The Public Hearing is a continuance from the April 15, 2020 meeting.

Ralph Cordova, attorney for Justo Felix provided a history/timeline of the project addressing issues with non-compliance of the conditions of approval as required. Stated that Mr. Felix is working with a local contractor to complete the work and feels that the work can be done in 6-7 weeks. Mr. Cordova asked that the following be made a part of the record:

E-mail letter from Ralph Cordova to Dennis Morita dated May 6, 2020; Letter to J. Carlos Fox, Esq from Dennis Morita dated March 25, 2020; and initial study dated April 2016 for Mitigated Negative Declaration.

Community Development Director MORA presented the staff report to Council that includes the violations of the Conditional Use Permit that led to the Planning Commission revoking the CUP and denial of Mr. Felix's request for time extension to comply.

Cory Van Driessche, Imperial resident addressed the Council of concerns with Mr. Felix operating outside of hours specified in the permit. Mr. Van Driessche provided documentation both written and videos. Mr. Van Driessche informed the Council that signatures from residents in the area of the business were collected in 2017 in opposition to the business at this location. Other concerns raised were the school bus stop to the east of the business and traffic.

Gabriel Lemus, truck driver for Mr. Felix for approximately 7 years spoke and was under the impression that he is losing his job because of noise issues. Mr. Lemus is not aware of non-compliance with CUP requirements.

Justo Felix, Owner of business spoke to council via his daughter Paulette Felix acting as translator. Stated he worked with Jesus Villegas, the city's project manager to assist with the process of obtaining water and sewer services to the property. An easement was granted to the city for infrastructure improvements. Mr. Felix stated that he has never had a fine or ticket from the police or sheriff departments or any vandalism of the property and has been supporter of Imperial schools and events. Mr. Felix requested the opportunity to comply with the CUP by obtaining an extension of an additional 3 months.

Darrell Pechtl speaking for the record, that at the time of the project approval he was a member of the Planning Commission. All elements for approval were outlined in 2015 even though the CUP was not issued until 2019. Mr. Felix needs to answer for non-compliance.
