ORDINANCE NO. 800

AN ORDINANCE OF THE CITY OF IMPERIAL AMENDING THE IMPERIAL CITY CODE TO CHANGE THE ZONING DESIGNATION FROM C-1 (COMMERCIAL NEIGHBORHOOD) TO R-A (RESIDENTIAL APARTMENT) FOR THE FOLLOWING APNS: 064-434-005, 064-434-006, AND 064-434-016

Pursuant to Section 24.19.600 et al, the City Council of the City of Imperial, State of California, does hereby ordain as follows:

<u>SECTION 1</u>: The "Official Zoning Map" of the City of Imperial, Imperial County, adopted at Section 24.01.140 of Chapter 24 of the Imperial City Code is hereby conditionally amended pursuant to Section 24.19.600, et seq. as set forth in this ordinance.

SECTION 2: The property affected by this ordinance is shown in Exhibit A, specifically known as APNS: 064-434-005, 064-434-006, AND 064-434-016

<u>SECTION 3</u>: The new zone for said property is hereby changed from C-1 Commercial Neighborhood to R-A (Residential Apartment)

<u>SECTION 5</u>: Effective Date. This Ordinance shall take effect and shall be in force thirty (30) days after the date of adoption, and prior to the expiration of fifteen (15) days from the passage thereof, shall be published at least once in a newspaper of general circulation printed and published in the County of Imperial, together with the names of the members of the City Council voting for and against the same.
