BACKGROUND/SUMMARY: The Imperial Valley United Soccer Association (IVUSA) is an organized sports program serving youth ages 4-14. IVUSA is a member of Cal South, which is a youth and adult state soccer association for Southern California. The 2019 fall soccer season is scheduled to begin September 9, 2019 and run through November 21, 2019. Imperial Valley United Soccer Association has reported serving a total of 1,025 Imperial Valley soccer players, with 308 of those children being City of Imperial residents. To serve the public interest and to assist in providing a fall soccer season, a Facility Use Agreement is recommended in order to provide the league the right to use the City's retention basin adjacent to Joshua Tree Park, which has turf and lighting.  In addition, IVUSA is requesting usage of lights at Joshua Tree retention basin. Due to lighting concerns, the lights will be limited for use Monday through Thursday, from sunset until 8:15 PM.  Imperial Valley United Soccer Association has provided a Certificate of Insurance, naming the City of Imperial as additionally insured.
