In **1999** the City of Imperial invested with Sun Community Federal Credit Union (SCFCU) a \$99,000.00 Certificate of Deposit (CD). Since then, the certificate has automatically rolled into a six (6) month term dividend. We are requesting your authorization to move the deposit from the current IRA to the Jumbo IRA with a sixty (60) month term. This will garner a higher yield than the current six (6) month term. Attached is a copy of the *IRA & Term Share Certificate* and the *Jumbo IRA & Term Share* terms, dividend rate and annual percentage yield (APY). As of September 30, 2018 the balance is \$102,383.86.

The City's current Investment Policy does not require Council action. However, for transparency purposes we are requesting your approval.
