This Addendum answers bidder's questions:

- 1. Is the City looking for Buffered bike lanes?
 - A. Yes
- 2. What is the budget for the PS&E?
 - A. No amount has been set for the preparation of plans, specifications, and estimates (PS&E).
- 3. Is this project grant-funded or city-funded?
 - A. As specified in the RFP documents, "funding from the Congestion Mitigation and Air Quality (CMAQ) Program, a federal-aid transportation program, will be applied for the construction of this project."
- 4. Do you have a date or period of time set aside for interviews, if needed?

 A. If needed, interviews will take place the week of November 21st.
- 5. Will construction be funded with State or Federal funds? If so, under which State or Federal program (e.g., State's Active Transportation Program)?
 - A. Federal Funds will be used for this project from the Congestion Mitigation and Air Quality (CMAQ) Program.
- 6. What does the City expect the selected consultant to provide as part of the "BID documents," aside from the final improvement plans, project construction specifications, and construction cost estimates as indicated in the RFP?
 - A. BID Documents are to include construction specifications as well as any documents needed for the Construction Bid Process as mentioned in question No. 7 below.

- 7. Typically a bid package includes not only the three components mentioned in #2, but also the administrative documents describing the bidding/contracting requirements of the City, as well as of State or Federal funding programs if such funds are being used for construction. Is the selected consultant or is the City responsible for providing the content for and packaging such administrative bid documents for bidding and contracting that are required by the City and funding agencies?
 - A. The consultant is responsible for providing the items described in this question. City has samples of BID Documentation from previous projects.
- 8. Is the project on Aten Blvd. or Aten Rd.? Google Maps only shows Aten Rd.
 - A. Within the limits of the City of Imperial it is Aten Boulevard.
