

### Memorandum of Understanding between the COUNTY OF IMPERIAL and the CITY OF IMPERIAL

This Memorandum of Understanding ("MOU") is made and entered into by and between the County of Imperial ("County"), a political subdivision of the State of California, and the City of Imperial ("City"), collectively referred to as the "parties".

WHEREAS, all of the parties agree that it is necessary to collaborate in order to provide for a parade and rally celebration honoring Heavyweight Boxing Champion Andy Ruiz Jr.; and

WHEREAS, the parties agree that the joint collaboration between the County and City in acknowledging and celebrating the victory of Mr. Andy Ruiz, Jr. provides public benefit to the citizens of both entities; and

WHEREAS, the County agrees to assist in providing reimbursement for half of the cost of expenses incurred, so long as the City agrees to pay the full cost of expenses and provide a detailed breakdown of total cost incurred; and

WHEREAS, the City agrees to assist in providing an invoice for half of the cost incurred for the celebration, so long as the County agrees to pay invoice within 30 days from date of issuance.

#### Now Therefore, the parties agree as follows:

- 1. The above recitals are true and correct and incorporated herein by reference.
- 2. Each party approves this MOU in order to establish a mutual understanding and cooperative process to.
  - The City agrees to pay full cost of expenses incurred.
  - 4. The County agrees to reimburse the City for half of the cost of expenses incurred.
