#### BACKGROUND/SUMMARY:

The City was able to secure funds for a transit park. Staff released an informal bid proposal to known labor consulting businesses in the Imperial Valley and Southern California Regions. Bid proposals were opened August 8, 2018. The project is scheduled to be completed by December 2018. The following four companies submitted proposals for labor compliance services:

- 1. Padilla & Associates \$29,069.32
- 2. Labor Compliance Consultants \$13,500.00
- 3. Alliant Consulting, Inc. \$12,680.00
- 4. TCG \$18,000.00

After carefully reviewing all proposals, Alliant Consulting seems to be the most advantageous to the city. The City has successfully worked with Alliant Consulting services on a couple other projects.
