BACKGROUND/SUMMARY:

The City of Imperial was awarded the SB 2 Grant by the State of California's Housing and Community Development Department. The grants purpose is to be used to accelerate housing production. The City will be utilizing the grant to prepare the identification and rezoning of certain R-1 (Residential Single-family) zones to R-A (Residential Apartment), up-zoning Commercial zones to include residential uses, and General Plan Amendments to accelerate housing production within the City of Imperial. Staff released an RFP for preparation services. The RFP was sent to known consultants and advertised on the City's website. Three (2) proposals were received:

- 1. Howes/Weiler/Landy
- 2. M.W. Steele Group

Howes/Weiler/Landy and Associates submitted a proposal in the amount of \$49,590.00. The fee will be paid out of SB 2 Grant Funds and Housing Funds.
